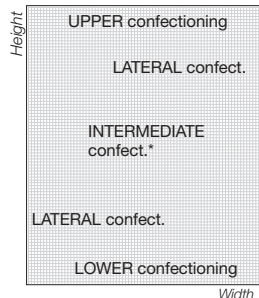

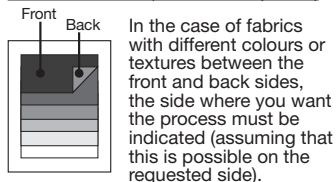
• Information notes (required for compiling)

1) Areas of fabric's processes



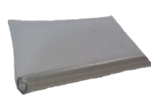
*Intermediate confectioning as horizontal seams are necessary when the required measurements are both greater than the roll's width/s of the fabric's measures.

Technical data sheet (for fabric's side process)



In the case of fabrics with different colours or textures between the front and back sides, the side where you want the process must be indicated (assuming that this is possible on the requested side).

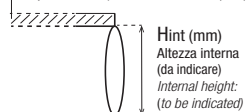

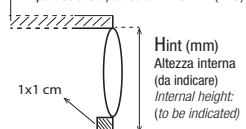


- **TOND Ø3 | Ø4,2 | Ø6:**

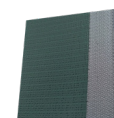
3) Vertical processes



- **BOTT PVC:**
PVC buttons



- **NAST BORD LAT:**
welding tape for lateral reinforcement of borders (suggested for S600-S601-Fabricscreen)



- **ZIP STD | OSC | PICC:**
zip standard (16 mm) / blackout (17 mm) / small (10 mm)

NOTE: zip's welding implicates that, in the total width measures, about:
for zip "standard" and "blackout":
+7 mm on left side
+7 mm on right side
for zip "small":
+5 mm on left side
+5 mm on right side

4) General notes on the processes

- Processes are feasible according to the chosen fabric type (see QR code above for more details)
- Pocket is made the same and always kept open on both sides (left and right), unless otherwise indicated
- Lateral confectioning are intended to be identical for both edges of the fabric, unless otherwise indicated
- Standard zip of white colour doesn't filter sunlight as grey and black colours
- Blackout zip, if applied to Marinello Tende's products, doesn't make the blind product 100% blackout, but it helps to limit the passage of sunlight in the lateral sides
- Refers to the offices for processes as prints, Greek decorations, Cristal+fabric configurations, support angular weldings applications, velcro, drommets applications or other specific processes. Refers to the offices for processes for acrylic fabrics Parà Tempotest, Starscreen and similar.
- For application of reinforcements, count their number starting from the bottom and indicate the distances between the various reinf. in the "Notes" space below.
